Terms and Conditions: Polish Science and Technology Summit at Berkeley 2024

- 1. General Information
 - These terms and conditions apply to all attendees, speakers, sponsors, and participants in the Polish Science and Technology Summit at Berkeley 2024 (the "Summit"), organized by Polish Club of Berkeley, registered student organization in collaboration with Silicone Baltic Bridge, non profit corporation, hereafter called "Organizers".
 - By registering for the Summit, you agree to abide by these terms and conditions.
- 2. Registration
 - Eligibility: Registration is open to individuals interested in science, technology, and innovation, particularly those with ties to Poland.

Registration Process:

- Participants must complete the registration form available on the official Summit website: https://polishclub.studentorg.berkeley.edu/conference.html.
- Registration is on a first-come, first-served basis, subject to space availability.
- Registrations are non-transferable.
- Registration Deadline: The deadline for registration is 10/11/2024. Late registrations may be subject to an additional fee or refusal, based on availability.
- 3. Registration Fees

Refund Policy:

- Refund requests must be submitted in writing by 09/30/2024.
- A full refund, minus a \$10 processing fee, will be issued for cancellations received by 09/30/2024.

No refunds will be given for cancellations after 09/30/2024, but substitutions may be allowed with prior approval.
